I understand that this release and waiver means I give up my right to bring any claims including for personal injuries, death, disease, property losses, or any other COVID Risks, including, but not limited to, claims of negligence, and I understand that this release and waiver prevents me from seeking damages in any way against SCTE, whether such damages are known or unknown, foreseen or unforeseen, or that occur now or in the future.

The undersigned waives any and all cause(s) of action which he or she may have against SCTE, its employees, agents, servants, or representatives, and/or which may arise as a result of the undersigned's participation in the Chapter Event.
